Do you have any "difficult" customers?

What is *Chamber University*?? It is a collaborative effort of the Upper Arlington Area, Grandview/Marble Cliff, Hilliard and Clintonville Chambers of Commerce. We wanted to give you another opportunity for networking and education.

In this first session, learn how to turn the challenging requests and complaints into a strategic advantage to grow more business. Sometimes customers get angry and it is a real test for any service provider. The typical approach in responding to complaints is with answers, yet many times jumping in too quickly with answers makes a bad situation worse. Sometimes service providers become angry or defensive themselves creating a standoff.

There are two equally fanatical approaches to customer service: (1) "The customer is always right," and (2) "the

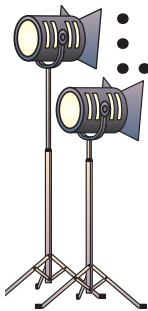
