

DTi Creative has also done some amazing things on the traditional front. They won a print award for their work on the City of Dublin's State of the City program. They have also been involved in creative props for

several D1 University's marching band half-time shows. This year alone, they have created designs for the University of Iowa, the University of Washington,

Penn State University, and of course, The Ohio State University Marching Band.

Matt's background was not always with Ohio State. He has a Bachelor of Fine Arts from the Columbus College of Art and Design, and he worked for several years for Battelle doing book layouts and other graphic design work. Later he gained experience at a local ad agency developing creative solutions to help
